



## Battle Participation General Requirements

**FUN!** Teams representing over 30 Dayton-area businesses compete in 12 co-ed sporting events over the course of 8 days.



Teams gain points in each event based on their overall placement versus other businesses. The

events range from sand volleyball to obstacle course.

**There's something for everyone!**

### Requirements of a Company Wanting to Participate?

- All participants must be on the company's payroll or contract employees who work at least 32 hours for the participating company.
- The minimum team size is 8 and must include at least 4 men and 4 women due to the co-ed nature of all events.
- The maximum team size is 30.
- Companies with less than 100 Dayton-based employees may include an immediate family member (limited to 1 family member per employee).
- All participants must be at least 19 years old.
- The entry fee for participating companies is \$450.00.

## Special Olympics Fund Raising

**BATTLE BUCKS** is the fund-raising portion of the Battle of the Businesses. The Battle is the number one fundraiser for Special Olympics of Greater Dayton. The Battle of the Businesses, on behalf of the participating companies, has donated to Special Olympics an average of \$70,000 annually.

The \$450 entry fee paid by each team goes to the running of the Battle, including team T-shirts, equipment, facility rental, etc. Everyone involved volunteers his or her time.

To thank the participants in the Battle Bucks campaign, raffle prizes will be available to all Battle Bucks participants. The chance to win raffle prizes will increase in proportion to the amount raised by each participant.

## Battle Events

**May 30, 2026**

**Sand Volleyball** – Games played against other teams in a tournament setting.

**May 31, 2026**

**Miniature Golf** – Participants play 18 holes.

**Cornhole Ladder** – Participants toss bags onto cornhole boards

**Trivia Night** – Team members answer questions from a variety of categories.

**June 1, 2026**

**Team Bowling** – Participants bowl three games.

**June 3, 2026**

**Team Ski** – Timed relay event on wooden skis in groups of four.

**Tug-of-War** – Participants tug against other teams in a tournament setting.

**June 6, 2026**

**Obstacle Course** – Timed event. Participants pass through a course of physical obstacles.

**Wind Sprint** – Timed relay. 4-100 meter legs.

**Punt, Pass & Place Kick** – Football skills.

**CEO Event** – Company administrators participate in a water balloon toss.

**Soccer Dribble** – Timed relay. Participants dribble soccer balls around cones.

**Sack Race** – Timed relay. Participants hop 4-15 yard legs and 2-20 yard legs.
